4. Sealed bid must be submitted to the General Post Office Dillibazar Kathmandu by hand/courier before 12:00 PM on 29, Bhadra 2078. Bids received after this deadline will be rejected.
5. Pre-bid meeting shall be held at General Post Office, Dillibazar Kathmandu on 18, Bhadra 2078
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM of Bhadra 29, 2078 at the office of General Post Office Dillibazar Kathmandu.
7. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, in the form of bank guarantee if the Nepalese bank or financial institution or original voucher (second copy) of cash deposit at District Treasury Controller Office Tripureshwor, Deposit Account No: 17000102030000, office code No: 358033506 amounting to a minimum of NRs 69000 (sixty nine thousand only), which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The purchaser reserves the right to accept or reject wholly or partially any or the bids without assigning reason, whatsoever prior to award of contract.

11. Any additional matters not covered by this shall be in accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation, 2064 of the GoN.
