4. Pre-bid meeting shall be held at 13:00 pm on the 2077/06/02 at GPO. Attendance is strongly advised for all prospective Bidders or their representatives, but is not mandatory.
5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before 12:00 pm on 2076/06/15 Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on the 2076/06/15 at the office of General Post Office, Dillibazar Kathmandu. Bids shall be opened even in the absence of the bidders or their authorized representatives.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Each bid must be accompanied by a separate Bid bond in the form of a bank guarantee if the Nepalese Bank or financial institution or Bank voucher of cash deposited at Rastriya Banijya Bank, Teku Branch Account No. 17000102030000 for an amount of NRs.66,220/- or its equivalent amount. Successful Bidders shall be required to furnish a performance Bond accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation,2064 before signing of Contract.
9. The Purchaser reserves the right to accept or reject wholly or partially any or the bids without assigning reason, whatsoever prior to award of contract.
